

ORDINANCE NO. 2005

AN ORDINANCE appropriating \$80,000.00 from the Growth Management Act Capital Projects Fund for the acquisition of additional open space property, and amending the Budget of the City of Camas for the year 1994 to provide for such expenditure.

WHEREAS, the City has negotiated for the acquisition of additional open space land for the City's greenway and open space network, and

WHEREAS, the estimated cost of such acquisition is \$80,000.00; and

WHEREAS, such expense was not budgeted in the 1994 Budget, and

WHEREAS, there are sufficient unappropriated funds in the Growth Management Act Capital Projects Fund to pay for such expenditure, now, therefore,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CAMAS AS FOLLOWS:

Section I

The sum of \$80,000.00 is hereby appropriated from unappropriated funds in the Growth Management Act Capital Projects Fund to pay for the acquisition of additional open space property, and is allocated as follows:
