

ORDINANCE NO. 2006

AN ORDINANCE appropriating \$80,000.00 from the Growth Management Act Capital Projects Fund for the acquisition of additional park land from James River Corporation, and amending the Budget of the City of Camas for the year 1994 to provide for such expenditure.

WHEREAS, the City has negotiated with James River Corporation for the acquisition of approximately 2.5 acres on East Eighth Street to be developed as additional park land, and

WHEREAS, the estimated cost of such acquisition is \$80,000.00; and

WHEREAS, such expense was not budgeted in the 1994 Budget, and

WHEREAS, there are sufficient unappropriated funds in the Growth Management Act Capital Projects Fund to pay for such expenditure, now, therefore,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CAMAS AS FOLLOWS:

Section I

The sum of \$80,000.00 is hereby appropriated from unappropriated funds in the Growth Management Act Capital Projects Fund to pay for the acquisition of additional park property, and is allocated as follows:

Section II

Ordinance 1965 and the Budget of the City of Camas for the year 1994 are amended to provide for the aforestated expenditure.

Section III




