

ORDINANCE NO. 2024

AN ORDINANCE appropriating the sum of \$15,000.00 from the Water/Sewer Fund to pay for the expense of transporting an accumulation of bio-solids from the waste water treatment plant and applying it at a different site.

WHEREAS, the health department has required the City to remove an accumulation of bio-solids from the waste water treatment plant and transport it to a different site, and

WHEREAS, the estimated cost of such project is \$15,000.00, and

WHEREAS, such expense was not provided for in the 1995 Budget, and

WHEREAS, there are sufficient unappropriated funds in the Water/Sewer Fund to pay for such expenditure, now, therefore

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CAMAS AS FOLLOWS:

Section I

The sum of \$15,000.00 is hereby appropriated from unappropriated funds in the Water/Sewer Fund and allocated as follows:
