

ORDINANCE NO. 2038

AN ORDINANCE appropriating \$84,350.00 from the general fund to pay for salaries and personnel benefits for employees granted cost of living increases and salary adjustments, and amending the budget for the year 1995 to provide for such expenditures.

WHEREAS, the City has heretofore adopted resolutions granting cost of living increases and salary adjustments to employees of the City, and

WHEREAS, the estimated cost of said cost of living increases and salary adjustments is \$84,350.00, and

WHEREAS, said expense was not provided for in the 1995 budget, and

WHEREAS, there are sufficient unappropriated funds in the general fund to pay for such expense, now therefore,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CAMAS AS FOLLOWS:

Section I

The sum of \$84,350.00 is hereby appropriated from unappropriated funds in the general fund to pay for cost of living adjustments and salary increases for employees of the City, and is allocated as set forth in Schedule A attached hereto and by this reference incorporated herein.

Section II

Ordinance 2011 and the budget for the City of Camas for the year 1995 are amended to provide for the aforestated expenditure.

Section III

This ordinance shall take force and be in effect five (5) days from and after its publication according to law.
