

ORDINANCE NO. 2039

AN ORDINANCE appropriating \$4,200.00 from the General Fund to pay for expenses associated with the City's Child Abuse and Domestic Violence Program, and amending the budget for the year 1995 to provide for such expenditure.

WHEREAS, the City has heretofore applied for and received a criminal justice training funds grant in the amount of \$4,171.39 to be utilized in the City's Child Abuse and Domestic Violence Program, and

WHEREAS, said grant funds have been deposited into the General Fund of the City, and

WHEREAS, the City desires to appropriate the sum of \$4,200.00 to pay for various expenses in connection with the Child Abuse and Domestic Violence Program, and

WHEREAS, there are sufficient unappropriated funds in the General Fund to pay for such expenditure, now, therefore, be it ordained by the Council of the City of Camas as follows:

Section I.

The sum of \$4,200.00 is hereby appropriated from unappropriated funds in the General Fund to pay for expenses in connection with the City's Child Abuse and Domestic Violence Program, and is allocated as follows:




Ordinance No. 2011 and the budget for the City of Camas for the year 1995 are amended to provide for the aforestated expenditure.


Section III.
