AN ORDINANCE appropriating \$5,000.00 from the General Fund to pay for consultant's fees to conduct an indoor air quality evaluation of City Hall.

WHEREAS, the City Council has determined that an evaluation should be made of the air quality in City Hall to determine whether current conditions pose a health hazard to city employees, and

WHEREAS, the estimated expense for such evaluation is \$5,000.00, and

WHEREAS, such expense was not provided for in the 1995 Budget, and

WHEREAS, there are sufficient unappropriated funds in the General Fund to pay for such expenditure, now, therefore

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CAMAS AS FOLLOWS:

Section I

The sum of \$5,000.00 is hereby appropriated from unappropriated funds in the General Fund and allocated as follows:
