

ORDINANCE NO. 2050

AN ORDINANCE amending Section 13.80.050(c)(2) by granting the Director of Public Works the authority to approve all locations for garbage containers, to require screening for garbage containers, and to approve the size of garbage containers.

THE COUNCIL OF THE CITY OF CAMAS DO ORDAIN AS FOLLOWS:

Section I

Section 13.80.050(c)(2) of the Camas Municipal Code is amended to provide as follows:

13.80.050 - Container Required.

C.2. All locations where containers are placed shall be subject to prior approval by the Public Works Director or his duly appointed designee. Approval of placement shall consider the standards of this Section and accessibility to City disposal trucks. The Director of Public Works or his duly authorized designee shall further have the authority to approve the size of garbage container and to impose screening requirements for garbage containers.

Section II

This ordinance shall take force and be in effect five (5) days from and after its publication according to law.
