

ORDINANCE NO. 2062

AN ORDINANCE transferring \$30,000.00 from the General Fund to the Street Fund, and appropriating \$30,000.00 from the Street Fund to pay for improvements to N.W. Lake Road, and amending the Budget for the Year 1996 to provide for such expenditure.

WHEREAS, when the Council adopted the 1996 budget, it appropriated moneys for the improvement of N.W. Lake Road, and

WHEREAS, the Council has heretofore called for bids on said project, and

WHEREAS, the lowest bid came in at \$30,000.00 over the budgeted amount, and

WHEREAS, the Council desires to proceed with said improvement, and there are sufficient unappropriated funds in the General Fund to pay for such additional costs, now, therefore,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CAMAS AS FOLLOWS:

Section I

The sum of \$30,000.00 is hereby transferred from the General Fund to the Street Fund.

Section II

The sum of \$30,000.00 is hereby appropriated from unappropriated funds in the Street Fund to pay that amount of the contract price in excess of the amount previously budgeted for improvements to N.W. Lake Road, and is allocated as follows:

Section III

Ordinance 2045 and the Budget of the City of Camas for the Year 1996 are amended to provide for the aforestated expenditure.

Section IV



Ordinance 2045 and the Budget of the City of Camas for the Year 1996 are amended to provide for the aforesaid expenditure.

#### Section IV

This ordinance shall take force and be in effect five (5) days from and after its publication according to law.
