

ORDINANCE NO. 2078

AN ORDINANCE appropriating \$84,000.00 from the General Fund to pay for unbudgeted repairs to the roof of the library building, and amending the Budget for the Year 1996 to provide for such expenditure.

WHEREAS, the City had previously budgeted \$92,000.00 for replacement of the roof on the library building, and

WHEREAS, the City has elected to undertake additional repairs to the library roof consisting of removal of wood planks under the existing tile roofing, installation of seismic anchors, and adding plywood sheathing to the entire existing roof, and

WHEREAS, the estimated cost of such additional repairs is \$84,000.00, and

WHEREAS, there are sufficient unappropriated funds in the General Fund to pay for such expenditure, now, therefore,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CAMAS AS FOLLOWS:

Section I

The sum of \$84,000.00 is hereby appropriated from the General Fund to pay for additional repairs to the roof of the library building, and is allocated as follows:

Section II

Ordinance 2045 and the Budget for the City of Camas for the Year 1996 are amended to provide for the aforestated expenditure.
