

ORDINANCE NO. 2080

AN ORDINANCE transferring \$50,000.00 from the General Fund to the Street Fund, appropriating \$50,000.00 from the Street Fund to pay for sidewalk improvements, and amending the Budget for the Year 1996 to provide for such expenditure.

WHEREAS, the City and Camas School District have adopted a walking hazard elimination safety program for young students attending the Camas schools, and

WHEREAS, the program requires the construction of sidewalks on portions of the west and east sides of N.E. Everett Street from N.E. 23rd Avenue to N.E. 14th Avenue, and

WHEREAS, the project requires construction of an additional sidewalk on N.E. 22nd Avenue, and

WHEREAS, the estimated cost of such sidewalk construction is \$50,000.00, and

WHEREAS, there are sufficient unappropriated funds in the General Fund to pay for such expenditure, now, therefore,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CAMAS AS FOLLOWS:

Section I

The sum of \$50,000.00 is hereby transferred from the General Fund to the Street Fund.

Section II

The sum of \$50,000.00 is hereby appropriated from the Street Fund to pay for sidewalk construction, and is allocated as follows:

Section III

Ordinance 2045 and the Budget for the City of Camas for the Year 1996 are amended to provide for the aforesated expenditure.

Section IV

This ordinance shall take force and be in effect five (5) days from its publication according to law.

AN ORDINANCE appropriating \$33,400.00 from the General Fund to pay for salaries and personnel benefits for an additional engineer technician in the Public Works Department and an accounting in the Finance Department, and amending the Budget for the Year 1996 to provide for such expenditure.
WHEREAS, the Public Works Department desires to add an additional engineer technician position and to fill that position during the summer months of 1996, and
WHEREAS, the Finance Department has created a new position of accountant and desires to fill that position in the summer of 1996, and
WHEREAS, the estimated cost for such additional employees is \$33,400.00, and
WHEREAS, there are sufficient unappropriated funds in the General Fund to pay for such expenditure, now, therefore,
BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CAMAS AS FOLLOWS:
Section I
The sum of \$33,400.00 is hereby appropriated from the General Fund to pay for salaries and personnel benefits for an additional engineering technician and a new accountant, and is allocated as follows:

Line Item: Salaries and Wages; Account No.: 001 13 513 200 11; Amount: \$12,000.00
Line Item: Personnel Benefits; Account No.: 001 13 513 200 21; Amount: \$13,200.00
