

ORDINANCE NO. 2110

AN ORDINANCE amending Chapter 13.84 of the Camas Municipal Code by revising the schedule of charges for the removal of refuse and solid waste.

THE COUNCIL OF THE CITY OF CAMAS DO ORDAIN AS FOLLOWS:

Section I

Section 13.84.010 of the Camas City Code is hereby amended to read as follows:

13.84.010 - Schedule of Charges. The following schedule of rates and prices shall be and the same are hereby adopted as a schedule of charges for the removal of refuse and solid waste by the City of Camas.

B. Carry-Out Rates. There shall be added to the applicable curbside rate a surcharge of twenty (20%) percent for all solid waste collections requiring carry-out service. Carry-out service rates shall apply when cans are placed so the collector must go in a building or up or down stairs, or when the solid waste collector is required to transport the customer's solid waste by hand a distance of more than ten (10) feet from its collection location to the solid waste collection vehicle.

C. Additional Charges. The City Council may from time-to-time adopt by resolution rates and charges for the collection and disposal of items of solid waste not provided for in Section 13.84.010(a).

D. Changes in service will become effective within two weeks of request.




Section 13.84.020 of the Camas Municipal Code is hereby amended to read as follows:
