

ORDINANCE NO. 2297

AN ORDINANCE revising the boundary lines of the electoral wards of the City of Camas and amending Chapter 1.20 of the Camas Municipal Code.

THE COUNCIL OF THE CITY OF CAMAS DO ORDAIN AS FOLLOWS:

Section I

Section 1.20.020 of the Camas City Code is amended to provide as follows:

Ward No. 1 of the City shall have the following boundaries:

Beginning at the intersection of Northwest 6th Avenue and Northwest Norwood thence north along NW Norwood Street to NW Maple Lane; thence easterly on NW Maple Lane to NW 8<sup>th</sup> Way; thence southeasterly on NW 8<sup>th</sup> way to NW Logan Street; thence northerly on Northwest Logan Street to Northwest 7th Avenue; thence east on Northwest 7th Avenue to NW Ivy Street; thence north on NW Ivy Street to NW 10<sup>th</sup> Avenue; thence east on NW 10<sup>th</sup> Avenue to NW Ivy Drive; thence northeasterly on Northwest Ivy Drive to Northwest 11th Avenue; thence east on Northwest 11th Avenue to NW Elm Street; thence south on NW Elm Street to NW 10<sup>th</sup> Avenue; thence east on NW 10<sup>th</sup> Avenue to Northwest Benton Drive; thence northeasterly on Northwest Benton Drive to Northwest 12th Avenue; thence west on NW 12<sup>th</sup> Avenue to NW Drake Way; thence north on NW Drake Way to NW 14<sup>th</sup> Avenue; thence west on NW 14<sup>th</sup> Avenue to NW Drake Street; thence north on NW Drake Street and the extension thereof to NW 18<sup>th</sup> Avenue; thence east on NW 18<sup>th</sup> Avenue to Division Street; thence north on Division Street to NW 19<sup>th</sup> Avenue; thence east on NW 19<sup>th</sup> Avenue to NE Everett Street; thence south on NE Everett Street to NE 15<sup>th</sup> Avenue; thence west on NE 15<sup>th</sup> Avenue to NE Dallas Street ; thence southerly on NE Dallas Street to NE 7<sup>th</sup> Avenue; thence easterly along the north line of block 56 and 55 of the plat of La Camas to NE Franklin Street; thence southerly on NE Franklin Street to NE 6<sup>th</sup> Avenue; thence easterly on NE 6<sup>th</sup> Avenue to NE Oak Street; thence southerly on NE Oak Street to NE 4<sup>th</sup> Avenue; thence westerly on NE 4<sup>th</sup> Avenue to NE Adams Street; thence southerly on NE Adams Street to Southeast 2nd Avenue; thence westerly along an extension of SE 2<sup>nd</sup> Avenue to the easterly shore of Lady Island; thence southerly along the east shore of Lady island to the eastern most point of said island; thence south to the Oregon-Washington border; thence westerly along Oregon- Washington border to the west Camas city limits boundary as described in Camas City Ordinance 1531; thence northerly along said ordinance line to SW 6<sup>th</sup> Avenue; thence easterly along SW 6<sup>th</sup> Avenue to State Route 14 interchange with SW 6<sup>th</sup> Avenue; thence northerly through the NW 6<sup>th</sup> interchange also being the west line of lots 4/8 and 3/7,8 of Glenwood Homestead to NW 6<sup>th</sup> Avenue; thence east along SW 6<sup>th</sup> Avenue to NW Norwood Street and the point of beginning. Section II

Section 1.20.030 of the Camas City Code is amended to provide as follows:

Ward No. 2 of the city shall have the following boundaries:

Beginning at the intersection of Northwest 18th Avenue and Division Street; thence west on Northwest 18th Avenue to Northwest 18th Loop; thence southwesterly and northwesterly on Northwest 18th Loop to Northwest Fargo Street; thence northerly on Northwest Fargo Street to Northwest 23<sup>rd</sup> Avenue; thence westerly on Northwest 23<sup>rd</sup> Avenue to NW Logan Street also being the extension of the east line of Summit Hills Condos phase II; thence south along said line to the southeast corner of Summit Hills Condos phase II; thence west along the south line of Summit Hills Condos Phase II and the extension thereof to the southeast corner of Skyview Subdivision; thence north along the east line of said subdivision to NW 28<sup>th</sup> Avenue; thence west along NW 28<sup>th</sup> Avenue to NW Sierra Drive; thence northerly along NW Sierra Drive to a point on the north line of Lacamas View Subdivision tract "C"; thence east along the north line of Lacamas View Subdivision tract "C" also being the south line of Lake Heights Subdivision to the

northeast corner of Lacamas View Subdivision tract "C" also being the south east corner of Lake Heights Subdivision ; thence northerly along the east line of Lake Heights Subdivision to Northwest Lake Road; thence northeasterly along the east boundary of Lacamas Shores Subdivision to the north city limits on Lacamas Lake, thence southeasterly along the north city limits as established by ordinance 1484 and 1721 to a point on Lacamas creek and the northerly extension of the east line of Short Plat 2-667; thence south along said extension and the east line and southerly extension of the east line of Short Plat 2-266 to NE 19<sup>th</sup> Avenue; thence east on NE 19<sup>th</sup> Avenue to NE Oak Street; thence southerly on NE Oak Street to NE 6<sup>th</sup> Avenue; thence westerly on NE 6<sup>th</sup> Avenue to NE Franklin Street; thence Northerly on NE Franklin Street to the northeast corner of block 55 of the plat of La Camas; thence westerly along block 55 and 56 of the plat of La Camas to NE Dallas Street; thence northerly along NE Dallas to NE 15<sup>th</sup> Avenue; thence east on NE 15 Avenue to NE Everett Street; thence north on NE Everett Street to NE 19<sup>th</sup> Avenue; thence west on NE 19<sup>th</sup> Avenue to Division Street; thence south on Division Street to NW 18<sup>th</sup> Avenue and the point of beginning. ### Section III

Section 1.20.040 of the Camas City Code is amended to provide as follows:

Ward No. 3 of the City shall have the following boundaries:

Beginning at the intersection of NW Dahlia Street and NW 38<sup>th</sup> Avenue; thence west on NW 38<sup>th</sup> Avenue to the west city limits boundary as described in ordinance 1518; thence northerly along the city limits line, to Southeast 1st Street; thence northerly along the west city limits boundary as of September 22, 1997, per Ordinance No. 2128, passing along Lacamas Creek and said boundary to the northwest corner of the Shipler Annexation, Ordinance No. 1484; thence southeasterly along the north city limits boundary on Lacamas Lake to the easterly boundary of Lacamas Shores Subdivision; thence along the easterly boundary of Lacamas Shores to Northwest Lake Road; thence south along the east line of Lake Heights Subdivision to the southwest corner of Lake Heights Subdivision also being the northeast corner of Lacamas View Subdivision tract "C"; thence west along the north line of Lacamas View Subdivision tract "C" to NW Sierra Drive; thence southerly along NW Sierra Drive to NW 28<sup>th</sup> Avenue; thence west on NW 28<sup>th</sup> Avenue to NW Utah Street; thence northerly on NW Utah Street to NW Valley Street; thence southerly on NW Valley Street to NW 29<sup>th</sup> Avenue; thence west on NW 29<sup>th</sup> Avenue to the west line of Prune Hill Park Subdivision; thence north along the west line of the Prune Hill Park Subdivision to the northwest corner of said subdivision; thence west along the extension of the north line of Prune Hill Park Subdivision to NW Dahlia Drive; thence northerly along NW Dahlia Drive to the point of beginning. ### Section IV

Section 1.20.050 of the Camas City Code is amended to prove as follows:

Ward No. 4 of the city shall have the following boundaries:

Beginning at the NE Adams Street and NE 4<sup>th</sup> Avenue; thence easterly along NE 4<sup>th</sup> Avenue to NE Oak Street; thence northerly on NE Oak Street to NE 19<sup>th</sup> Avenue; thence west on NE 19<sup>th</sup> Avenue to the intersection of the southerly extension of the east line of Short Plat 2-667; thence north along the extension of the said line and the northerly extension of said line to the intersection with Lacamas Creek; thence southerly along Lacamas Creek to NE 3<sup>rd</sup> Avenue; thence easterly on Northeast 3rd Avenue to Southeast Crown Road; thence northerly on Southeast Crown Road to the north city limits boundary as of October 1, 1994; thence easterly on the north city limits line to the northwest corner of lot 1, Section 12, T1N, R3E, W.M.; thence easterly along the south line of the Washougal annexation described in Resolution 914 to Southeast Shepherd Road ; thence easterly along the city limits boundary as described in

Ordinance 1206 to an intersection with the Washougal River and Northeast 3rd Avenue; thence southeasterly on Northeast 3rd Avenue to Northeast Weir Street; thence north on Northeast Weir Street to Northeast 4th Avenue; thence easterly on Northeast 4th Avenue to Northeast Lechner Street; thence southerly on Lechner Street to the Burlington Northern Railroad Tracks; thence westerly along the tracks to Southeast Whitney Street; thence northerly on Southeast Whitney Street to a point where the city limits line bears westerly; thence westerly along the south city limits line to a point where said line bears southerly; thence southerly along the city limits line to the south line of the State of Washington, Clark County, and the City of Camas; thence westerly along said south line to a point that bears south from the eastern most point of Lady's Island; thence northerly along the east shore of Lady's Island, crossing State Highway 14 to an intersection of the westerly extension of SE 2<sup>nd</sup> Avenue; thence east along the extension of SE 2<sup>nd</sup> Avenue to NE Adams Street; thence northerly along NE Adams Street to the point of beginning. #### Section V

Section 1.20.060 of the Camas City Code is amended to provide as follows:

Ward No. 5 of the city shall have the following boundaries:

Beginning at the intersection of Northwest Brady Road and NW McIntosh Road; thence northerly along the west camas city limits boundary as described in Ordinance 1747 and 1518 to NW 38<sup>th</sup> Avenue; thence east along NW 38<sup>th</sup> Avenue to NW Dahlia Street; thence southerly along NW Dahlia Street to the intersection with the westerly extension of the north line of Prune Hill Park Subdivision; thence east along said extension to the northwest corner of Prune Hill Park Subdivision; thence south along the west line of Prune Hill Park Subdivision to NW 29<sup>th</sup> Avenue; thence east along NW 29<sup>th</sup> Avenue to NW Valley Street; thence northerly along NW Valley Street to NW Utah Street; thence southerly along NW Utah Street to NW 28<sup>th</sup> Avenue; thence westerly along NW 28<sup>th</sup> Avenue to NW Cascade Street; thence southerly along NW Cascade Street to NW 25<sup>th</sup> Avenue; thence east along NW 25<sup>th</sup> Avenue to a point on the east line of Columbia Summit Subdivision; thence south along the east line of Columbia Summit Subdivision crossing NW 23<sup>rd</sup> Avenue and continuing south along NW Astor Street to NW 11<sup>th</sup> Avenue; thence west on NW 11<sup>th</sup> Avenue to NW McIntosh Road; thence westerly along NW McIntosh Road to the point of beginning. #### Section VI

Section 1.20.070 of the Camas City Code is amended to provide as follows:

Ward No. 6 of the city shall have the following boundaries:


Beginning at the intersection of Northwest 6th Avenue and Northwest Norwood; thence north along NW Norwood Street to NW Maple Lane; thence easterly on NW Maple Lane to NW 8<sup>th</sup> Way; thence southeasterly on NW 8<sup>th</sup> way to NW Logan Street; thence northerly on Northwest Logan Street to Northwest 7th Avenue; thence east on Northwest 7th Avenue to NW Ivy Street; thence north on NW Ivy Street to NW 10<sup>th</sup> Avenue; thence east on NW 10<sup>th</sup> Avenue to NW Ivy Drive; thence northeasterly on Northwest Ivy Drive to Northwest 11th Avenue; thence east on Northwest 11th Avenue to NW Elm Street; thence south on NW Elm Street to NW 10<sup>th</sup> Avenue; thence east on NW 10<sup>th</sup> Avenue to Northwest Benton Drive; thence northeasterly on Northwest Benton Drive to Northwest 12th Avenue; thence west on NW 12<sup>th</sup> Avenue to NW Drake Way; thence north on NW Drake Way to NW 14<sup>th</sup> Avenue; thence west on NW 14<sup>th</sup> Avenue to NW Drake Street; thence north on NW Drake Street and the extension thereof to NW 18<sup>th</sup> Avenue; thence west on NW 18<sup>th</sup> Avenue to NW 18<sup>th</sup> Loop; thence southwesterly and northwesterly on Northwest 18th Loop to Northwest Fargo Street; thence northerly on Northwest Fargo Street to Northwest 23<sup>rd</sup> Avenue; thence westerly on Northwest 23<sup>rd</sup> Avenue to NW Logan Street also being the extension of the east line of Summit Hills Condos phase II; thence south along said line to the southeast corner of Summit Hills Condos phase II; thence west along the south line of Summit Hills Condos Phase II and the extension thereof to the southeast corner of Skyview Subdivision; thence north along the east line of said subdivision to NW 28<sup>th</sup> Avenue;


thence west along NW 28<sup>th</sup> Avenue to NW Cascade Street; thence southerly along NW Cascade Street to NW 25<sup>th</sup> Avenue; thence east along NW 25<sup>th</sup> Avenue to a point on the east line of Columbia Summit Subdivision; thence south along the east line of Columbia Summit Subdivision crossing NW 23<sup>rd</sup> Avenue and continuing south along NW Astor Street to NW 11<sup>th</sup> Avenue; thence west on NW 11<sup>th</sup> Avenue to NW McIntosh Road; thence westerly along NW McIntosh Road to NW Brady Road; thence south along the west city limits boundary as described in Ordinance 1531 to SW 6<sup>th</sup> Avenue; thence easterly along SW 6<sup>th</sup> Avenue to State Route 14 interchange with SW 6<sup>th</sup> Avenue; thence northerly through the NW 6<sup>th</sup> interchange also being the west line of lots 4/8 and 3/7,8 of Glenwood Homestead to NW 6<sup>th</sup> Avenue; thence east along SW 6<sup>th</sup> Avenue to NW Norwood Street and the point of beginning. Section VII


This ordinance shall take force and be in effect five (5) days from and after its publication according to law.
