

ORDINANCE NO. 2342

AN ORDINANCE adopting by reference certain provisions of the Revised Code of Washington constituting misdemeanors and gross misdemeanors.

THE COUNCIL OF THE CITY OF CAMAS DO ORDAIN AS FOLLOWS:

Section I

The following sections of the Revised Code of Washington are hereby adopted by reference, for inclusion within Section 9.36.010A of the Camas Municipal Code:

Section II



Section III


This ordinance shall take force and be in effect five (5) days from and after its publication according to law.
